## WHAT IS A COMMUNITY FOUNDATION?

Calling them "community foundations" is far from accidental since foundations exist to benefit local communities they serve. All community foundations are nonprofit organizations that exist for and from the general population they serve. Earnings from endowed funds established by various individuals, organizations, corporations and even casual groups of friends with a common charitable vision allow a community to serve itself through the community foundation, lessening the dependence on tax dollar or other government support.

All community foundations have two constituents: the donor and the grantee. Naturally, grants cannot be made without a donor; therefore, the wishes of donors become a top priority. Donors who desire to establish an endowed fund or give to an existing fund may wish to have their generosity recognized or choose to remain anonymous. It is quite common for an endowed fund to be established to memorialize or honor a loved one.

Community foundations are a conduit for charitable giving. A donor does not actually give to the community foundation. Rather, the gift travels through the community foundation. Most community foundations are structured to handle gifts of all sizes. By accepting gifts, both large and small, the community foundation makes it possible for everyone to be a philanthropist.

# HISTORY OF THE COMMUNITY FOUNDATION

 $m{T}$  he Community Foundation of Southwest Kansas began as a dream of nine residents of Southwest Kansas in 1991. These individuals, referred to as the original nine incorporators, had a vision of the positive possibilities that would result in the creation of a community foundation in the Dodge City area.

The Foundation received its initial tax-exempt status notification from the IRS in September 1992. Other significant milestones include successfully recruiting founders to fund the "Founders Endowment" to cover operating expenses and receiving a significant endowment from St. Mary of the Plains that funded the Scholarship Fund.

In September of 1999, the foundation changed its name from the Dodge City Area Community Foundation. The change was made to better reflect the geographic area the Community Foundation serves. Since that time, ten area towns have established funds for the benefit of their respective communities.

The organization was born by individual acts of philanthropy to insure the future educational, health, leadership and quality of life needs in southwest Kansas. Since inception the Foundation has awarded over 5,176 scholarships totaling \$4,604,153. From 1996 to 2022 a total of 2,513 grants have been funded for a total of 11.8 million.

A truly amazing fact; the Foundation experienced phenomenal growth with only a part-time director. At midyear 2001, the Foundation hired its first full-time director.

The Community Foundation began fiscal year 2001 with 25 named funds and ended fiscal 2022 with 153 named funds. This growth can be directly attributed to the Foundation involvement with the Kansas Health Foundation and the successful completion of several campaigns that involved matching funds. The title program, "Grow Healthy Kansas" continues to bring substantial benefits and growth to our Foundation and the communities we serve.

To the Community Foundation partners, which include donors, volunteers and the Kansas Health Foundation, we thank you for your commitment to the success of the Community Foundation.





### **CELEBRATING DIVERSITY**

Dodge City is one of the most diverse communities in Kansas. It is home to people from literally all over the world. Individuals and families have traveled from all parts of Latin America, Africa, Asia, and countless other countries to make this their home. Not to mention, Dodge City Public Schools serves students from forty-five different countries and over twenty different languages.

### LIFT MINNEOLA CHILDCARE PROJECT

Southwest Kansas is filled with opportunity, and it is a wonderful place to have a family and raise children. However, living in Southwest Kansas can also come with its share of challenges. One of the major challenges presently facing families in Southwest Kansas is accessible and affordable childcare. Therefore, the community of Minneola decided to take a proactive approach on this issue and begin work on the Leading Into the Future Together (LIFT) Minneola Childcare Project. LIFT Minneola is a volunteer grassroots organization which was born out of a desire to grow their community.

In 2019, starting with casual conversations on sidewalks and amongst businesses, several individuals collectively agreed to purposely identify needs and projects to enhance the quality of life in Minneola. Based on those conversations with community members and businesses it didn't take long for the LIFT members to realize that the number one issue facing Minneola was accessible and affordable childcare.

As with many smaller rural communities in Southwest Kansas, Minneola has a couple of in-home childcare providers, but no childcare centers. Consequently, with a number of children being under 6 years of age, parents are struggling to find childcare for their children. Moreover, due to a lack of access to childcare and combined with the high costs of childcare, many parents have chosen to forgo outside employment and stay home to care for their children, which has had a negative economic development impact upon the family and the community.

With a lack of accessible and affordable childcare being identified as the number one issue facing the community, the next step was to a find a solution to the problem. Recognizing that low profit margins, and lack of suitable structures made it difficult for individuals to start and operate a childcare facility, members of LIFT came to realize that this was where the solution to Minneola's childcare issues had to start, with the infrastructure.

Therefore, the priority for the LIFT team became finding a place suitable to meet their childcare needs. A building which previously housed a church congregation, became available. The layout of the church building allows for conversion into two separate business spaces which, can be renovated to support two off-site residentially licensed childcare operations.

With a building now secured the next step is to renovate the church building into an updated structure for use as a safe and affordable childcare option for Minneola families. LIFT Minneola stated, "We are grateful to the Community Foundation of Southwest Kansas for their generous donation, which will be used for renovations of the structure. We thank them for walking this walk with us."

### THE LANCER CENTER


Kevin & Shelley Kolbeck of Spearville, had a vision of opening a facility that would provide a safe, wholesome, and entertaining place for the teenagers of Spearville to gather. As lifetime residents of Ford County, and teachers within the Spearville school system, they saw a need for young people to have a place where they could just hang out, play games, recharge, and step away from their everyday stresses and circumstances. Their idea was to find a place where special events & activities could be planned specifically for young people to engage, learn a new skill, or simply unwind from their busy schedules and rejuvenate their souls.

From that vision, the Lancer Center was formed. The Spearville community saw the Lancer Center as a means of coming together and showing their young people that they valued them and were willing to invest their time and resources into their lives and well-being. Therefore, in September of 2022, the Lancer Center obtained possession of the former First National Bank building for the purpose of turning a concept into a reality. The first order of business was to renovate the former bank building and to create a space that would fit the needs of Spearville's youth.

The Community Foundation of Southwest Kansas has a long history of supporting youth programs and youth initiatives. Therefore, when the Foundation received a grant request to help provide support to renovate the former bank building. The request aligned directly with the Community Foundation's mission of providing educational and social opportunities for communities.

Today, the Lancer Center is home to an air hockey table, a Skeet-Ball alley game, table tennis, and a 9 square game. The Center also contains four couches, two recliners, tables & chairs for games or eating, and a big screen TV.

On any given Friday or Saturday night, you can find 35-40 students at the Center participating in everything from a game of air hockey to learning how to two step, swing, polka or line dance. What started as a vision has become a reality, where young people can gather in a safe place, have a good time, participate in special events, and learn life skills along the way.



### **CORE COMMUNITY/MEADE COUNTY**

The Community Foundation of Southwest Kansas strives to bring positive change to people's lives and communities. Core Community of Meade County shares in that endeavor.

What if there was a safe place/group where you could meet once a week, share a meal, share your struggles, plan for a future, set goals, gain knowledge, and receive support from others with the same intent? That is what Core Community is.

Core Community was designed to heal lives, solve generational poverty, which in turn empowers individuals and communities for greatness. Often, poverty is defined as a financial deficit. However, Core Community takes a wholistic approach to the issue of poverty. One can have money and property and still live in poverty. Therefore, poverty is defined as a lack of *resources* not just a lack of finances.

Core Community has identified 11 different areas where a person might be impoverished. Poverty can be financial, but equally, it can be emotional, mental, spiritual, physical, language, social capital, integrity & trust, relationships/role models, knowledge of middle-class rules, and motivation & persistence.

By focusing on those 11 key areas of poverty, and giving people the proper encouragement, love, and skills that they need to overcome, Core Community participants have been able to achieve some amazing things. Here are just a handful of examples of how Core Community is not just changing the lives of the individual, but the life of a community.

- #1 Purchased a home.
- #2 Paid off a Pay Day Loan, while also spending more time with their kids, and became a Core Community Advisory Board Member.
- #3 Directing the Meade County Food Bank, while also starting a support group for women, as well as helping others with rides to appointments.
- #4 Went from no job to a full-time job. Now has full coverage health insurance and is getting new glasses. Also, is involved at church playing the piano and is working on becoming less co-dependent.
- #5 Got a part time job. Has joined a support group, a Bible Study and is developing more wholesome friendships in the community. Also, helping to assist others in the group with transportation and friendship.

Core Community participant said; "We are learning self-improvement and avenues on how to deal with difficult issues. I like input from others who have better or different ideas that are outside the group".

Core Community offers a long-term solution to help individuals and families break the generational poverty cycle. Core Community changes lives and helps communities thrive.

### FORD COUNTY HISTORICAL SOCIETY

The Community Foundation of Southwest Kansas and the Historical Society have a storied relationship of preserving Ford County's history and legacy. From that storied relationship the Foundation and the Historical Society have been able to preserve and honor some of the most important historical sites and people in the history of Dodge City and Ford County.

Such projects included the renovation of the Mueller-Schmidt House (aka Home of Stone), which is Dodge City's oldest home. Built to be one of the most splendid homes in Dodge City, Ford County's "Home of Stone" lives up to this, even today. It remains the lone limestone house in Dodge City, elegant in its simplicity of line. It can also claim the distinction of being the oldest building in Dodge City that is still on its original site. You can still see the parlor, kitchen, bedrooms, and the exterior of the Mueller-Schmidt House as it was in 1881.

Recently, in June of 2022 a 6-foot bronze statue was dedicated in honor of Dodge City lawman Bat Masterson. Bat was famous for his exploits as an Army scout, lawman, professional gambler, and journalist. The Bat Masterson statue can be found in the front of the Home of Stone.

Future projects will include a statue that will pay homage to one of Ford County's most famous residents, Dennis Hopper. Mr. Hopper was an American actor, filmmaker, and photographer. His most famous role was in the iconic movie Easy Rider, which also served as Hopper's directing debut.

The crowning achievement includes the formation of the Ford County Legacy Center. The Legacy Center is 22,000 sq. ft. facility located on Gunsmoke Street. The Legacy Center will allow Ford County and Dodge City's twentieth century history to be documented and open to both the local and visiting public.

Studying and preserving history helps us to understand how events in the past impacted what we see today. With lessons from the past, we not only learn about ourselves and how we came to be, but also develop the ability to avoid mistakes and create better paths for our societies.

The Community Foundation of Southwest Kansas is committed to improving the quality of life in Dodge City and Southwest Kansas. Supporting projects that preserve our past facilitates the fulfilling of that mission.



#### **SUNNYSIDE POP**

The Sunnyside POP Fund was started by a retired teacher over 12 years ago. The "Pass-through" fund is designed to benefit Sunnyside Elementary School.

The "POP" part of Sunnyside POP stands for Private Opportunity Program. The special after school programs are not funded with public money. Fund raisers, grants and donations are used to fund these projects and programs. Over the past 12 years over 650 students have participated in POP activities.

The first program offered to the Sunnyside students was the after-school art program. To qualify for the art program students had to be on their best behavior. In other words, students were required to be well behaved in order to stay after school.

The art program consisted of more than just drawing pictures. Students are introduced to the "Masters." The art teacher fastened the canvas to the bottom of the student's desk so they would have to work laying down, painting overhead. This allowed the future artist to relate to, if not appreciate, Renaissance Master Michelangelo's challenges in painting the Sistine Chapel.

Every school year, since 2011, ends with the Sunnyside School art show. The art show is hosted by the students themselves. You are escorted through the hallways by one of the student/artists who will interpret some of the more abstract works on display. Over the years, one particular piece of art has had a lasting effect. A young man's impression of post-impressionist Vincent van Gogh's masterpiece: "Starry Night." Yes, he nailed van Gogh's work but in the fore ground was a Walmart store. The impressionist must have made an impression because all these years later "Starry Night" is vividly remembered.

Fast forward several years and the Sunnyside POP program has expanded to include a variety of different activities. Students now have the opportunity to participate in art, music, crafts, Lego Club, sports programs, and museum visits.

The Community Foundation of Southwest Kansas motto is "Lighting the way for future generations". Through POP programs and activities students are able to cultivate their ability to think critically, work as a team, set goals, improve upon academic success, and to have their hearts and minds touched in ways we may never know. Plus, POP is simply just a lot of fun.

### IN MEMORY OF NED LOWRY

Ned Lowry was born May 26, 1933, in Northern Kansas on the family farm and ranch. Mr. Lowry worked in the oil and gas industry for nearly 50 years. At the age of 19, he began his career working on a pulling unit south of Logan, Kansas, moving a year later to Norton, Kansas pumping wells. In 1955, Ned heard of an oil boom in Kimball, Nebraska, so he took a risk and pulled up stakes, moving his family there, where he found employment with Petroleum, Inc. Over the next 19 years he worked his way up the ranks with the company, moving to Norman, Oklahoma in 1958, then to Liberal, Kansas in 1966 as the district superintendent. Ned recognized a need in the oil and gas industry and seized the opportunity. In 1974, he started Lowry's Lease Management, Inc., a lease management service, managing properties for small oil and gas companies not located in the mid-west. He and Dorothy worked very hard building the business, many times making deals with a gentleman's handshake, until retiring in 2002. In addition to Ned's business savvy, he was also very philanthropic. In 2017, Ned and his wife Dorothy established the Ned & Dorothy Lowry Endowment Fund with the Community Foundation of Southwest Kansas. Their endowment fund has help support a number of area non-profits with project and operational support.

Tim spent his childhood and youth on the family farm in rural Ulysses, Kansas where his early childhood education was at a one room schoolhouse. Tim would go on to attend schools in Ulysses and graduate from Ulysses High School in 1966.

Upon graduation from high school, Tim would continue his art education at Dodge City Community College and then later in New Mexico, where he would earn a degree in Art and Art Education. Mr. Schoonover returned to Dodge City in 1970, beginning his career as an Art teacher at Dodge City Junior High School. Tim loved his students and teaching. In 1991 he received the Kansas Art Educator Award.

Tim was also part of a group of western Kansas art teachers that spearheaded the founding of the Western Kansas Scholastic Art Awards, which are a part of the National Scholastic Art Awards. Many of Tim's students would go on to win both State and National Scholastic Art Awards in Photography.

In addition to his art, Tim was also an active member of the community. Tim and his wife Alice were founding members of the Community Foundation of Southwest Kansas, and Tim enjoyed working as a member of the Foundation's scholarship committee. In 2008, Tim and Alice additionally started the Tim & Alice Endowed Fund. Through the years their fund has helped support several important projects and services in the area.
